7 **A Resolution confirming an award by the Board of Control of professional service contract**  
8 **renewal (second of two) with Akron Community Service Center and Urban League, Inc.,**  
9 **for adult ex-offender employment services, for the period 7/1/15 through 6/30/16, in a total**  
10 **amount not to exceed \$200,000.00, for the Executive's Department of Job and Family**  
11 **Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held March 25, 2015, awarded  
14 professional service contract renewal (second of two) with Akron Community Service Center  
15 and Urban League, Inc., for adult ex-offender employment services, for the period 7/1/15  
16 through 6/30/16, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the contract renewal is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of professional service contract renewal (second of  
27 two) with Akron Community Service Center and Urban League, Inc., for adult ex-offender  
28 employment services, for the period 7/1/15 through 6/30/16, in a total amount not to exceed  
29 \$200,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
30 contract renewal.

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide for ex-offender employment services effective 7/1/15.

38 SECTION 3

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,  
49 were in meetings open to the public, in compliance with all legal requirements, including Section  
50 121.22 of the Ohio Revised Code.


