7 **A Resolution authorizing the County Executive to advertise for bids for a vendor to**  
8 **provide payroll services for the 2015 Summer Youth Employment Program, for the period**  
9 **5/15/15 through 9/30/15, for an estimated total cost not to exceed \$1,825,000.00, for youth**  
10 **wages, corresponding taxes and administrative fees, for the Executive's Department of Job**  
11 **and Family Services, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council's authorization for the County Executive to advertise for bids; and

15  
16 WHEREAS, the County Executive wishes to advertise for bids for a vendor to provide  
17 payroll services for the 2015 Summer Youth Employment Program, for the period 5/15/15  
18 through 9/30/15, for youth wages, corresponding taxes, and administrative fees; and

20 WHEREAS, a copy of the bid specifications is attached as Exhibit A; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
24 advertise for bids for the aforementioned services;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that;

31 The County Executive is authorized to advertise for bids for a vendor to provide payroll  
32 services for the 2015 Summer Youth Employment Program, for the period 5/15/15 through  
33 9/30/15, per attached Exhibit A, for an estimated total cost not to exceed \$1,825,000.00, for  
34 youth wages, corresponding taxes, and administrative fees.

38 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
39 of the citizens of the County of Summit, and for the further reason that it authorizes the  
40 Executive to immediately advertise for bids for payroll services for the 2015 Summer Youth  
41 Employment Program effective 5/15/15.
