7 **A Resolution authorizing the County Executive to execute a subgrant agreement with the**  
8 **Ohio Department of Job and Family Services for grants received by the County of Summit**  
9 **Child Support Enforcement Agency during State Fiscal Years 2016 and 2017 (July 1, 2015**  
10 **to June 30, 2017), for the Prosecutor – Child Support Enforcement Agency , and declaring**  
11 **an emergency.**

13 WHEREAS, Section 5101.21 of the Ohio Revised Code states that, commencing July 1,  
14 2008, the Ohio Department of Job and Family Services may only make grants to counties  
15 through subgrant agreements as described in that Section; and

16  
17 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, the Ohio  
18 Department of Job and Family Services developed a standard subgrant agreement to be executed  
19 by the commissioners of each county prior to receiving Department of Job and Family Services  
20 grant funds; and

21  
22 WHEREAS, the County of Summit Child Support Enforcement Agency has received  
23 from the Ohio Department of Job and Family Services the standard subgrant agreement for State  
24 Fiscal Years (“SFY”) 2016 and 2017 that sets forth the rights and responsibilities of both the  
25 Ohio Department of Job and Family Services and the County of Summit Child Support  
26 Enforcement Agency in relation to any grant that is awarded for SFY 2016 and 2017; and

28 WHEREAS, the County of Summit Child Support Enforcement Agency anticipates  
29 receiving grant funds from the Ohio Department of Job and Family Services for SFY 2016 and  
30 2017; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that it is necessary and in the best interest of the County of Summit to authorize the County  
34 Executive to execute said subgrant agreement for SFY 2016 and 2017;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
37 of Ohio, that:

39 SECTION 1

41 The County Executive is hereby authorized to execute a subgrant agreement with the  
42 Ohio Department of Job and Family Services for grants received by the County of Summit Child  
43 Support Enforcement Agency for State Fiscal Years (“SFY”) 2016 and 2017 (July 1, 2015 to  
44 June 30, 2017). A copy of said subgrant agreement is attached to this Resolution as Exhibit A  
45 and is incorporated herein as if fully restated.

4 SECTION 2

6 This Resolution is hereby declared an emergency in the interest of the health, safety and  
7 welfare of the citizens of the County of Summit, and for the further reason that it is necessary to  
8 immediately execute said subgrant agreement so that the County of Summit Child Support  
9 Enforcement Agency is eligible to awarded grant funds from the Ohio Department of Job and  
10 Family Services for SFY 2016 and 2017.

12 SECTION 3

14 Provided this Resolution receives the affirmative vote of eight members, it shall take  
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
16 effect and shall be in force at the earliest time provided by law.

20 It is found and determined that all formal action of this Council concerning and relating  
21 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
22 deliberations of this Council and of any of its committees that resulted in such formal action,
