7 **A Resolution, pursuant to Section 177.19 of the Codified Ordinances of the County of**  
8 **Summit, authorizing the disposal of certain surplus firearms by the Sheriff through trade-**  
9 **in, in the amount of \$22,282.00, against the purchase of new supplies from Pro Armament**  
10 **Company, for the Sheriff, and declaring an emergency.**

11  
12 WHEREAS, the County Sheriff is in the possession of certain surplus firearms, as set  
13 forth in Exhibit A attached to this Resolution, that are no longer needed for use by the Sheriff's  
14 office; and

15  
16 WHEREAS, the County Sheriff and County Executive have determined that disposal of  
17 said surplus firearms is necessary, and have received an offer from Pro Armanent Company to  
18 trade in said firearms for the amount of \$22,282.00 against the purchase of new supplies; and

19  
20 WHEREAS, pursuant to Section 177.19 of the Codified Ordinances of the County of  
21 Summit, personal property cumulatively exceeding \$15,000.00 may be sold without a public  
22 auction or sealed bids if this Council finds good cause as to why a public auction or sealed bid is  
23 not warranted; and

25 WHEREAS, this Council hereby finds that good cause exists not to sell said surplus  
26 firearms at a public auction or sealed bid and to instead deal directly with a dealer serving the  
27 law enforcement community; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
30 that it is necessary and in the best interest of the County to authorize the disposal of said surplus  
31 firearms by the Sheriff through trade in, in the amount of \$22,282.00, against the purchase of  
32 new supplies from Pro Armament Company;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that:

37 SECTION 1

39 This Council hereby authorizes, pursuant to Section 177.19 of the Codified Ordinances of  
40 the County of Summit, the disposal of certain surplus firearms by the Sheriff through trade in, in  
41 the amount of \$22,282.00, against the purchase of new supplies from Pro Armament Company.  
42 An itemization of the surplus firearms authorized to be disposed of above is attached to this  
43 Resolution as Exhibit A and incorporated herein as if fully restated.

45 SECTION 2

47 This Resolution is hereby declared an emergency in the interest of the health, safety and  
48 welfare of the citizens of the County of Summit, and for the further reason of immediately  
49 disposing of said surplus firearms and proceeding with purchasing of new supplies.
