7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **BioFire Defense, LLC, for one hazmat portable bio-detection system, in an amount not to**
9 **exceed \$56,000.00, for the Executive's Department of Law, Insurance and Risk**
10 **Management – Division of Public Safety/EMA, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 1, 2015, awarded a purchase
13 contract with BioFire Defense, LLC, for one BioFire Razor Ex hazmat portable bio-detection
14 system, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the purchase contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a purchase contract with BioFire Defense, LLC,
25 for one BioFire Razor Ex hazmat portable bio-detection system, in an amount not to exceed
26 \$56,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such
27 purchase contract.

29 SECTION 2

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the bio-detection system in 2015.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

43 It is found and determined that all formal actions of this Council concerning and relating
44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,

47 121.22 of the Ohio Revised Code.
