7 **A Resolution confirming an award by the Board of Control of a purchase order with E-**

13 order with E-Tactics, Inc., for electronic data transfer and print/mail services, for Fiscal Year
14 2015, as Best Practical Source, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a purchase order with E-Tactics, Inc., for electronic
25 data transfer and print/mail services, for Fiscal Year 2015, as Best Practical Source, in an amount
26 not to exceed \$38,000.00, is hereby confirmed and the County Executive is hereby authorized to
27 execute such purchase order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide electronic data transfer and print/mail services for Fiscal Year 2015.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,
