7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **JoMac Truck Bodies and Cranes, Ltd., for two vehicle utility service bodies for two 2015**  
9 **Ford F550 four-wheel drive trucks, in an amount not to exceed \$33,660.39 each, for a total**  
10 **amount not to exceed \$67,320.78, for the Executive's Department of Environmental**  
11 **Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held April 22, 2015, awarded a purchase  
14 contract with JoMac Truck Bodies and Cranes, Ltd., for the purchase of two vehicle utility  
15 service bodies for two 2015 Ford F550 four-wheel drive trucks, subject to confirmation by  
16 County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the purchase contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

26 The award by the Board of Control of a purchase contract with JoMac Truck Bodies and  
27 Cranes, Ltd., for the purchase of two vehicle utility service bodies for two 2015 Ford F550 four-  
28 wheel drive trucks, in an amount not to exceed \$33,660.39 each, for a total amount not to exceed  
29 \$67,320.78, is hereby confirmed and the County Executive is hereby authorized to execute such  
30 purchase contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide the vehicle utility service bodies in 2015.

38 SECTION 3

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action,  
49 were in meetings open to the public, in compliance with all legal requirements, including Section  
50 121.22 of the Ohio Revised Code.
