7 **A Resolution confirming an award by the Board of Control of a construction contract with**  
8 **A & A Safety, Inc., for the 2015 Summit County Pavement Marking Program, in an**  
9 **amount not to exceed \$147,012.50, for the Engineer, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held April 22, 2015, awarded a  
12 construction contract with A & A Safety, Inc., for the 2015 Summit County Pavement Marking  
13 Program, subject to confirmation by County Council; and

15 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
16 that the contract is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
19 of Ohio, that:

21 SECTION 1

23 The award by the Board of Control of a construction contract with A & A Safety, Inc., for  
24 the 2015 Summit County Pavement Marking Program, in an amount not to exceed \$147,012.50,  
25 is hereby confirmed and the County Executive is hereby authorized to execute such contract.

27 SECTION 2

29 This Resolution is hereby declared an emergency in the interest of the health, safety and  
30 welfare of the citizens of the County of Summit, and for the further reason to immediately  
31 provide for the pavement marking program in 2015.

33 SECTION 3

35 Provided this Resolution receives the affirmative vote of eight members, it shall take  
36 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
37 effect and be in force at the earliest time provided by law.

41 It is found and determined that all formal actions of this Council concerning and relating  
42 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
43 deliberations of this Council and of any of its committees that resulted in such formal action,  
44 were in meetings open to the public, in compliance with all legal requirements, including Section  
45 121.22 of the Ohio Revised Code.


