7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award by the Supreme Court of Ohio of a Technology Grant, for the period**  
9 **4/17/15 through 9/1/15, in the amount of \$11,398.56, and appropriating grant funds for**  
10 **expenditures in calendar year 2015, for the Court of Common Pleas – Juvenile Division,**  
11 **and declaring an emergency.**

12  
13 WHEREAS, the Ohio Supreme Court has awarded a Technology Grant to the Court of  
14 Common Pleas – Juvenile Division, for the period 4/17/15 through 9/1/15, in the amount of  
15 \$11,398.56, with a total cost of \$24,230.06 to consolidate six of the Court’s outdated physical  
16 servers; and

17 WHEREAS, the total cost of the project is \$24,230.06 and the remaining cost of  
18 \$12,831.50 will be coming from the Court’s Special project fund; and

19  
20 WHEREAS, replacing the server will improve performance, and significantly decrease  
21 support, maintenance, and energy cost. The upgrade will also allow Juvenile Court to more  
22 readily interface with the Ohio Courts Network;

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
26 execute any documents necessary to accept the award of the aforementioned grant from the  
27 Supreme Court of Ohio, and to appropriate grant funds;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that:

34 The County Executive is hereby authorized to execute any documents necessary to accept  
35 the award by the Supreme Court of Ohio of a Technology Grant, for the period 4/17/15 through  
36 9/1/15, in the amount of \$11,398.56, with a total project cost of \$24,230.06, with the amount of  
37 \$12,831.50 coming from the Court’s Special project fund.
