7 **A Resolution authorizing the County Executive to advertise for bids for the County**
8 **Engineer's Administration Building Roof Replacement Project, for an estimated total cost**
9 **not to exceed \$101,100.00, for the Executive's Department of Administrative Services –**
10 **Physical Plants, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the County Engineer's
16 Administration Building Roof Replacement Project, in Council District 4; and

18 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that is necessary and in the best interest of the County of Summit to authorize the Executive to
22 advertise for bids for the aforementioned project;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that;

29 The County Executive is authorized to advertise for bids for the County Engineer's
30 Administration Building Roof Replacement Project, in Council District 4, for an estimated total
31 cost not to exceed \$101,100.00.

35 This Resolution is declared an emergency in the interest of the health, safety, and welfare
36 of the citizens of the County of Summit, and for the further reason that it authorizes the
37 Executive to immediately advertise for bids for the County Engineer's Administration Building
38 Roof Replacement Project due to its poor condition and to prevent leaking during rain storms.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
