9 **Act grant, for the period 10/1/14 through 9/30/15, in the amount of \$3,524.52, with no local**
10 **cash match requirement, and appropriating funds, for the Prosecutor’s Child Support**
11 **Enforcement Agency, and declaring an emergency.**

13 WHEREAS, the County Prosecutor’s Office has received an award from the Ohio
14 Attorney General’s Office of a Federal Fiscal Year (“FFY”) 2015 Victims of Crime Act
15 (“VOCA”) grant, for the period 10/1/14 through 9/30/15, in the amount of \$3,524.52, with no
16 local cash match requirement; and

18 WHEREAS, the grant is to purchase laptops for victims advocates funded by the
19 VOCA/SVAA grants; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
23 execute any documents necessary to accept the award of the aforementioned grant from the
24 Ohio Attorney General’s Office, and to appropriate these grant funds;
