7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to an**
8 **intra-governmental agreement with the County Executive's Department of**
9 **Communications, for additional supervisors for the Summer Youth Employment Program,**
10 **for the period 5/1/15 through 9/30/15, in an amount not to exceed \$64,982.00 (63.01%**
11 **increase), for the Executive's Department of Job and Family Services, and declaring an**
12 **emergency.**

14 WHEREAS, this Council previously adopted Resolution No. 2015-177, which approved
15 Summer Youth Employment Program agreements with certain providers, for monitoring services
16 and work readiness skills classes, for the period 5/1/15 through 9/30/15; and

18 WHEREAS, one of the providers, the County Executive's Department of
19 Communications, needs additional supervisors to provide enhanced oversight at youth worksites
20 and assistance with timesheet collection and review to ensure timely and accurate payroll
21 submissions, for the period 5/1/15 through 9/30/15; and

23 WHEREAS, the Board of Control, at its meeting held May 27, 2015, awarded Change
24 Order No. 1 to an intra-governmental agreement with the County Executive's Department of
25 Communications, for additional supervisors to provide enhanced oversight at youth worksites
26 and assistance with timesheet collection and review to ensure timely and accurate payroll
27 submissions, for the period 5/1/15 through 9/30/15, subject to confirmation by County Council;

30 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
31 that the change order is necessary and in the best interest of the County of Summit;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

38 The award by the Board of Control of Change Order No. 1 to an intra-governmental
39 agreement with the County Executive's Department of Communications, for additional
40 supervisors for the Summer Youth Employment Program, to provide enhanced oversight at
41 youth worksites and assistance with timesheet collection and review to ensure timely and
42 accurate payroll submissions, for the period 5/1/15 through 9/30/15, in an amount not to exceed
43 \$64,982.00 (63.01% increase), is hereby confirmed and the County Executive is hereby
44 authorized to execute such change order.
