7 **An amended Ordinance amending certain sections of Chapter 169 of the Codified**
8 **Ordinances of the County of Summit, entitled “Personnel Policies and Procedures,” and**
9 **enacting new Section 169.33 of the Codified Ordinances, for the Executive’s Department of**
10 **Human Resources and the Human Resource Commission, and declaring an emergency.**

12 WHEREAS, after a review by the County Executive’s Department of Human Resources
13 and the Human Resource Commission Administrator, it was determined that it is necessary to
14 make certain changes to Sections 169.01, 169.02, 169.04, 169.11, 169.16, 169.17, 169.20,
15 169.22, 169.25 and 169.28 through 169.32 of the Codified Ordinances of the County of Summit,
16 and to enact new Section 169.33 of the Codified Ordinances, entitled “Report of Violation of
17 Statutes or Rules by Employee;” and

19 WHEREAS, it is necessary for County Council to adopt legislation implementing the
20 recommended revisions to the aforementioned sections of Chapter 169 and to enact new Section
21 169.33; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary to amend Sections 169.01, 169.02, 169.04, 169.11, 169.16, 169.17, 169.20,
25 169.22, 169.25, and 169.28 through 169.32 of the Codified Ordinances of the County of Summit,
26 and to enact new Section 169.33 of the Codified Ordinances;

28 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
29 of Ohio, that:

33 Sections 169.01, 169.02, 169.04, 169.11, 169.16, 169.17, 169.20, 169.22, 169.25 and
34 169.28 through 169.32 of the Codified Ordinances of the County of Summit are hereby amended
35 and new Section 169.33 of the Codified Ordinances, entitled “Report of Violation of Statutes or
36 Rules by Employee;” is hereby amended, as shown on Amended Exhibit A, attached hereto and
37 incorporated herein as if fully restated.

41 This Ordinance is hereby declared an emergency in the interest of the health, safety and
42 welfare of the citizens of the County of Summit, and for the further reason of immediately
43 amending Sections 169.01, 169.02, 169.04, 169.11, 169.16, 169.17, 169.20, 169.22, 169.25 and
44 169.28 through 169.32 of the Codified Ordinances of the County of Summit and enacting new
45 Section 169.33 of the Codified Ordinances in order to immediately implement a more efficient
46 human resource system in the County.

50 Provided this Ordinance receives the affirmative vote of eight members, it shall take
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
52 effect and be in force at the earliest time provided by law.
