7 **A Resolution approving the new classification, classification specification and salary**
8 **schedule for the non-bargaining, classified position of Chief Hearing Officer #29706 and**
9 **renumbering the non-bargaining classified position of Child Support Administrator as**
10 **class code #29707, for the Human Resource Commission and the Executive's Department**
11 **of Human Resources, and declaring an emergency.**

13 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10)
14 of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
15 Codified Ordinances to establish classifications, classification specifications and pay/salary
16 schedules for all County employees; and

18 WHEREAS, the County Prosecutor has requested pursuant to Sections 169.11 that the
19 classification, classification specification and salary schedule for the non-bargaining classified
20 position of Chief Hearing Officer #29706 be approved, resulting in the renumbering of the non-
21 bargaining classified position of Child Support Administrator #29706 as Child Support
22 Administrator #29707; and

24 WHEREAS, at its June 18, 2015 meeting, the Human Resource Commission approved
25 the classification, classification specification and salary schedule for the classified non-
26 bargaining position of Chief Hearing Officer, #29706, as stated in Order 15-02, attached hereto
27 as Exhibit A and incorporated herein as if fully restated; and

29 WHEREAS, at its June 18, 2015 meeting, the Human Resource Commission further
30 approved renumbering the non-bargaining classified position of Child Support Administrator
31 #29706 as Child Support Administrator #29707, as stated in Order 15-03, attached hereto as
32 Exhibit B and incorporated herein as if fully restated; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 it is necessary and in the best interest of the County of Summit to approve the new classification,
36 classification specification and salary schedule for the non-bargaining classified position of
37 Chief Hearing Officer #29706 and to renumbering of the non-bargaining classified position
38 Child Support Administrator as class code #29707;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

6 The classification specification for the new non-bargaining classified position of Chief
7 Hearing Officer #29706, which is attached hereto as Exhibit C and incorporated herein as if fully
8 restated, is hereby approved. The aforementioned classification is assigned the salary schedule
9 of Category C2, Grade 9, as indicated in Exhibit D, attached hereto and incorporated herein as if
10 fully restated.

14 The non-bargaining classification of Child Support Administrator #29706 is hereby
15 renumbered as:

17 **Child Support Administrator #29707 – Category: C3 Grade 5**

19 The renumbered non-bargaining classified position of Child Support Administrator
20 #29707 is shown in the County of Summit Classification/Compensation Plan, which is attached
21 hereto as Exhibit E. The salary schedule shall remain the same.

23 SECTION 4

25 This Resolution is hereby declared an emergency in the interest of the health, safety and
26 welfare of the citizens and employees of the County of Summit, and for the further reason that it
27 is necessary in order to immediately approve a new classification, classification specification and
28 salary schedule for the new non-bargaining classified position of Chief Hearing Officer #29706
29 and to immediately re-number of the classification of Child Support Administrator as class code
30 #29707.

32 SECTION 5

34 Provided this Resolution receives the affirmative vote of eight (8) members, it shall take
35 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
36 and be in force at the earliest time provided by law.

41 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
