7 **A Resolution confirming an award by the Board of Control of a 60-month lease with**
8 **ComDoc, Inc. for five Xerox copiers under Northeast Ohio Sourcing Office pricing, for a**
9 **total amount not to exceed \$54,960.00, for the Prosecutor, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held May 27, 2015, awarded a 60-
12 month lease with ComDoc, Inc. for five Xerox copiers under Northeast Ohio Sourcing Office
13 pricing, for an amount not to exceed \$916.00 per month or an amount not to exceed \$10,922.00
14 per year, for a total amount not to exceed \$54,960.00 during the 60-month term of the lease,
15 approved by the Information and Technology Board on 5/26/15, subject to confirmation by
16 County Council; and

18 WHEREAS, the lease with ComDoc, Inc. is exempt from competitive bidding as a
19 contract for equipment through any other public cooperative purchasing associations, including,
20 but not limited to, the Northeast Ohio Sourcing Office, pursuant to Section 177.07(a)(11) of the
21 Codified Ordinances of the County of Summit; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the aforementioned lease with ComDoc, Inc. is necessary and in the best interest of the
25 County of Summit;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The award by the Board of Control of a 60-month lease with ComDoc, Inc. for five
33 Xerox copiers under Northeast Ohio Sourcing Office pricing, for an amount not to exceed
34 \$916.00 per month or an amount not to exceed \$10,922.00 per year, for a total amount not to
35 exceed \$54,960.00 during the 60-month term of the lease, approved by the Information and
36 Technology Board on 5/26/15, is hereby confirmed and the County Executive is hereby
37 authorized to execute such lease.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the citizens of the County of Summit, and for the further reason to immediately
43 provide for a necessary lease of copiers for the Prosecutor's Office.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.


