7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Summit County Public Health to provide substance abuse screening and**
9 **counseling for youth in detention, for the period 7/1/15 through 6/30/16, in a total amount**
10 **not to exceed \$55,346.00, for the Court of Common Pleas – Juvenile Division, and declaring**
11 **an emergency.**

13 WHEREAS, the Board of Control, at its meeting held June 24, 2015, awarded a
14 professional service contract with Summit County Public Health to provide substance abuse
15 screening and counseling for youth in detention, for the period 7/1/15 through 6/30/16, in a total
16 amount not to exceed \$55,346.00, subject to confirmation by County Council; and

18 WHEREAS, the professional service contract with Summit Public Health is exempt from
19 competitive bidding as a contract with another governmental unit pursuant to Section
20 177.07(a)(2) of the Codified Ordinances of the County of Summit; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned professional service contracts are necessary and in the best interest of the
24 County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

29 SECTION 1

31 The award by the Board of Control of a professional service contract with Summit
32 County Public Health to provide substance abuse screening and counseling for youth in
33 detention, for the period 7/1/15 through 6/30/16, in a total amount not to exceed \$55,346.00, is
34 hereby confirmed and the County Executive is hereby authorized to execute such professional
35 service contracts.

37 SECTION 2

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit, and for the further reason to immediately
41 provide substance abuse screening and counseling for youth in detention effective 7/1/15.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
