7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Job and Family Services of a State Fiscal**
9 **Year 2016 Connecting the Dots grant, for the period 7/1/15 through 12/31/15, in the amount**
10 **of \$175,145.00, with no local cash match requirement, and appropriating funds, for the**
11 **Executive’s Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the County Executive’s Department of Job and Family Services
14 (“SCDJFS”) has received notification of an award from the Ohio Department of Job and Family
15 Services (“ODJFS”) of federal funds in the form of a State Fiscal Year 2016 (“SFY 2016”)
16 Connecting the Dots grant, in the amount of \$175,145.00, with no local cash match requirement;

19 WHEREAS, these funds will enable SCDJFS to operate a Connecting the Dots program
20 within SFY 2016, for the period 7/1/15 through 12/31/15, with the purpose of improving the
21 educational and employment outcomes for Summit County youth aging out of foster care and
22 supporting their transition to adulthood; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
26 execute any documents necessary to accept the award from of the aforementioned grant and to
27 appropriate the total grant award for the period ending 12/31/15;

34 The County Executive is hereby authorized to execute any documents necessary to accept
35 an award from the Ohio Department of Job and Family Services (“ODJFS”) of a State Fiscal

37 Family Services, for the period 7/1/15 through 12/31/15, in the amount of \$175,145.00, with no
38 local cash match requirement.
