7 **A Resolution authorizing the County Executive to advertise for bids for the Fishcreek Roof**
8 **Replacement Project, for an estimated total cost not to exceed \$284,000.00, for the**
9 **Executive's Department of Environmental Services, and declaring an emergency.**

11 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
12 requires this Council's authorization for the County Executive to advertise for bids; and

13
14 WHEREAS, this Council previously adopted Resolution No. 2015-185, which authorized
15 the County Executive to advertise for bids for the Fishcreek Roof Replacement Project, to
16 replace the roofs on the Administration Building and the Filter Building, in the City of Stow, in
17 Council District 3, for an estimated total cost not to exceed \$213,800.00; and

19 WHEREAS, the County received only one response to the advertisement for bids which
20 exceeded the estimated total cost not to exceed \$213,800.00; and

21
22 WHEREAS, the Executive wishes to advertise a second time for bids for the Fishcreek
23 Roof Replacement Project, for an estimated total cost not to exceed \$284,000.00; and

25 WHEREAS, a copy of the bid specifications are attached to this Resolution as Exhibit A;

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
30 advertise for bids for the Fishcreek Roof Replacement Project for an estimated total cost not to
31 exceed \$284,000.00;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that;

38 The County Executive is authorized to advertise for bids for the Fishcreek Roof
39 Replacement Project to replace the roofs on the Administration Building and the Filter Building,
40 in the City of Stow, in Council District 3, for an estimated total cost not to exceed \$284,000.00.

44 This Resolution is declared an emergency in the interest of the health, safety, and welfare
45 of the citizens of the County of Summit, and for the further reason that it authorizes the
46 Executive to immediately advertise for bids for the Fishcreek Roof Replacement Project in
47 Council District 3.
