7 **A Resolution confirming an award by the Board of Control of an intergovernmental**
8 **agreement with Summit County Public Health to increase utilization of Healthchek Early,**
9 **Periodic, Screening, Diagnostic and Testing services for young children, for the period**
10 **10/1/15 through 9/30/16, in an amount not to exceed \$60,000.00, for the Executive's**
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held July 15, 2015, awarded an
14 intergovernmental agreement with the Summit County Public Health to increase utilization of
15 Healthchek Early, Periodic, Screening, Diagnostic and Testing ("EPSDT") services for young
16 children, which is a Medicaid program that provides prevention, diagnosis and treatment services
17 for early identification and treatment of health problems, for the period 10/1/15 through 9/30/16,
18 in an amount not to exceed \$60,000.00, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned intergovernmental agreement is necessary and in the best interest of the
22 County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

29 The award by the Board of Control of an intergovernmental agreement with the Summit
30 County Public Health to increase utilization of Healthchek Early, Periodic, Screening, Diagnostic
31 and Testing ("EPSDT") services for young children, which is a Medicaid program that provides
32 prevention, diagnosis and treatment services for early identification and treatment of health
33 problems, for the period 10/1/15 through 9/30/16, in an amount not to exceed \$60,000.00, is
34 hereby confirmed and the County Executive is hereby authorized to execute such
35 intergovernmental agreement.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit, and for the further reason to immediately
41 provide for increased utilization of Healthchek Early, Periodic, Screening, Diagnostic and
42 Testing services for young children effective 10/1/15.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
