7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Community Legal Aid Services, Inc., for legal services for a period of 10/1/15**  
9 **through 9/30/16, in an amount not to exceed \$116,000.00, for the Executive's Department of**  
10 **Job and Family Services, and declaring an emergency.**

11  
12 WHEREAS, the Board of Control, at its meeting held July 15, 2015, awarded a  
13 professional service contract with Community Legal Aid Services, Inc., for legal services related  
14 to housing issues, kinship care, expungement, consumer issues, individualized education plans,  
15 domestic violence, driver's license suspension removal, bankruptcy filing, consumer debt,  
16 guardianship/custody for kinship care and public benefits such as Supplemental Security Income,  
17 Social Security Disability Insurance and Unemployment for a period of 10/1/15 through 9/30/16,  
18 in an amount not to exceed \$116,000.00, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, by reviewing all pertinent information,  
21 that the change order is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

28 The award by the Board of Control of a professional service contract with Community  
29 Legal Aid Services, Inc., for legal services related to housing issues, kinship care, expungement,  
30 consumer issues, individualized education plans, domestic violence, driver's license suspension  
31 removal, bankruptcy filing, consumer debt, guardianship/custody for kinship care and public  
32 benefits such as Supplemental Security Income, Social Security Disability Insurance and  
33 Unemployment for a period of 10/1/15 through 9/30/16, in an amount not to exceed \$116,000.00,  
34 is hereby confirmed and the County Executive is hereby authorized to execute such professional  
35 service contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and  
40 welfare of the citizens of the County of Summit, and for the further reason to immediately  
41 provide legal services effective 10/1/15.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.


