7 **A Resolution increasing appropriations, in the amount of \$3,390.00, in the Prosecutor's**
8 **Victims of Crime Act Grant, for the period 10/1/14 through 9/30/15, for the Prosecutor,**
9 **and declaring an emergency.**

11 WHEREAS, this Council previously approved Resolution No. 2014-483 which
12 authorized the County Executive to execute any documents necessary to accept an award from
13 the State of Ohio Attorney General's Office of a Federal Fiscal Year 2015 Victims of Crime Act
14 ("VOCA") Grant in the amount of \$83,125.61, with a local cash match requirement of 25% in
15 the amount of \$27,708.55, for a VOCA award total of \$110,834.16, for the period 10/1/14
16 through 9/30/15; and

18 WHEREAS, the VOCA Grant is to provide travel and training dollars for administrative
19 staff providing advocacy services to crime victims in Summit County; and

20
21 WHEREAS, the County Prosecutor was awarded additional funding from the Ohio
22 Attorney General's Office totaling \$2,712.00, requiring a 20% cash match of \$678.00, to send
23 two Victim Advocates to the 2016 National Organization for Victim Assistance conference; and

25 WHEREAS, the cash match will be paid from the County Prosecutor's General Fund
26 budget; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that is necessary and in the best interest of the County of Summit to increase appropriations in
30 the Prosecutor's Victims of Crime Act Grant for 2015 for the aforementioned reasons;
