7 **A Resolution appropriating funds in the amount of \$9,360.00, for the administration of the**  
8 **distribution of fuel fund assistance through the 2015-2016 Fuel Fund Grant Program to**  
9 **assist low income electric customers, for the Executive's Department of Community and**  
10 **Economic Development, and declaring an emergency.**

12 WHEREAS, the Ohio Edison Company, the Cleveland Electric Illuminating Company  
13 and the Toledo Edison Company have agreed to provide funding, as approved by the Public  
14 Utilities Commission of Ohio in Case No. 12-1230-EL-SSO, to implement and support a fuel  
15 fund program to provide financial assistance to eligible customers toward payment of their  
16 electric bill; and

18 WHEREAS, Council adopted Resolution No. 2015-097 which authorized the Executive  
19 to execute any documents necessary to act as an agent for the distribution of fuel fund assistance  
20 through the 2015-2016 Fuel Fund Grant Program to assist low income electric customers;
