7 **A Resolution adjusting existing appropriations by \$11,215.83 within the Community**  
8 **Corrections Act Adult Probation Intensive Supervision grant for State Fiscal Year 2015,**  
9 **ending 6/30/15, for the Executive's Department of Law, Insurance and Risk Management –**  
10 **Division of Public Safety, and declaring an emergency.**

11  
12 WHEREAS, County Council previously adopted Resolution No. 2014-202, which  
13 authorized the County Executive to execute any documents necessary to accept the award from  
14 the State of Ohio Department of Rehabilitation and Correction ("ODRC"), through the  
15 Community Corrections Act ("CCA"), of a 407 grant for State Fiscal Year 2015, in the amount  
16 of \$1,239,107.00, with no local cash match requirement, for community corrections programs to  
17 be operated by the Court of Common Pleas - Adult Probation Department and Oriana House,  
18 Inc., for the period 7/1/14 through 6/30/15; and

20 WHEREAS, Council also previously adopted Resolution No. 2014-204, which  
21 authorized the County Executive to execute any documents necessary to accept the award from  
22 the ODRC, through the CCA, of a 408 grant for State Fiscal Year 2015, in the amount of  
23 \$448,759.00, with no local cash match requirement, for community corrections programs to be  
24 operated by the County Sheriff and Oriana House, Inc., for the period 7/1/14 through 6/30/15;

27 WHEREAS, the adjustment of existing appropriations by \$11,215.83 within the  
28 Community Corrections Act Adult Probation Intensive Supervision grant for State Fiscal Year  
29 2015, ending 6/30/15, is required to best meet the needs of the Court of Common Pleas - Adult  
30 Probation Department; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that the aforementioned appropriations adjustment is necessary and in the best interest of the  
34 County of Summit;

13 the appropriations by \$11,215.83 within the Community Corrections Act Adult Probation  
14 Intensive Supervision grant for State Fiscal Year 2015, ending 6/30/15, is immediately needed to  
15 better meet the needs of the Court of Common Pleas - Adult Probation Department.

20 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take

29 121.22 of the Ohio Revised Code.


