7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Greenleaf Family Center to provide Supporting Partnerships to Assure**  
9 **Ready Kids services, for a one-year term, from 10/1/15 through 9/30/16, in an amount not**  
10 **to exceed \$55,000.00, for the Executive's Department of Job and Family Services, and**  
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 12, 2015, awarded a  
14 professional service contract with Greenleaf Family Center to provide Supporting Partnerships to  
15 Assure Ready Kids services, for a one-year term, from 10/1/15 through 9/30/16, in an amount  
16 not to exceed \$55,000.00, subject to confirmation by County Council; and,

17  
18 WHEREAS, pursuant to Section 5101:9-4-07(A)(2) of the Ohio Administrative Code,  
19 which conforms to Federal regulations, the services to be provided by Greenleaf Family Center  
20 which will be funded by Title XX and Temporary Assistance for Needy Families grant funds, are  
21 exempt from competitive bidding requirements due to Greenleaf Family Center's status as a  
22 subgrantee; and

24 WHEREAS, County Council has determined by reviewing all pertinent information that  
25 the aforementioned professional service contract with Greenleaf Family Center is necessary and  
26 in the best interest of the County of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

31 SECTION 1

33 The award by the Board of Control of a professional service contract with Greenleaf  
34 Family Center to provide Supporting Partnerships to Assure Ready Kids services, for a one-year  
35 term, from 10/1/15 through 9/30/16, in an amount not to exceed \$55,000.00, is hereby confirmed  
36 and the County Executive is hereby authorized to execute such contract.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and  
41 welfare of the citizens of the County of Summit, and for the further reason to provide Supporting  
42 Partnerships to Assure Ready Kids services effective 10/1/15.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.
