7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Opportunity Parish Ecumenical Ministry to provide case management**
9 **services for Bridges Out of Poverty class graduates from the Ministry's class sites, for a**
10 **one-year term, from 10/1/15 through 9/30/16, in an amount not to exceed \$80,000.00, for**
11 **the Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Bridges Out of Poverty ("BOP") is a model used to assist low income
14 BOP class participants in creating and implementing plans for transitioning out of poverty, while
15 utilizing case management and mentoring services; and

16
17 WHEREAS, the Board of Control, at its meeting August 12, 2015, awarded a
18 professional service contract with Opportunity Parish Ecumenical Ministry to provide case
19 management services for Bridges Out of Poverty class graduates from the Ministry's class sites,
20 for a one-year term, from 10/1/15 through 9/30/16, in an amount not to exceed \$80,000.00,
21 subject to confirmation by County Council; and

23 WHEREAS, pursuant to Section 5101:9-4-07(A)(2) of the Ohio Administrative Code,
24 which conforms to Federal regulations, the services to be provided by Opportunity Parish
25 Ecumenical Ministry, which will be funded by Temporary Assistance for Needy Families grant
26 funds, are exempt from competitive bidding requirements due the Ministry's status as a
27 subgrantee; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that the aforementioned professional service contract with Opportunity Parish Ecumenical
31 Ministry is necessary and in the best interest of the County of Summit;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The award by the Board of Control of a professional service contract with Opportunity
39 Parish Ecumenical Ministry to provide case management services for Bridges Out of Poverty
40 class graduates from the Ministry's class sites, for a one-year term, from 10/1/15 through
41 9/30/16, in an amount not to exceed \$80,000.00, is hereby confirmed and the County Executive
42 is hereby authorized to execute such professional service contract.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens of the County of Summit, and for the further reason to immediately
48 authorize the Executive to execute a necessary professional service contract for Bridges Out of
49 Poverty class graduates effective 10/1/15.
