7 **A Resolution authorizing the County Executive to execute a subgrant agreement with the**
8 **Ohio Department of Job and Family Services for grants for the operation of workforce**
9 **development activities for Local Area 2 received by the County Executive's Department of**
10 **Job and Family Services during State Fiscal Year 2016 (7/1/15-6/30/16), for the Executive's**
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, Section 5101.21 of the Ohio Revised Code provides that the Ohio
14 Department of Job and Family Services may only make grants to counties through subgrant
15 agreements described in that Section; and

16
17 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, the Ohio
18 Department of Job and Family Services developed a standard subgrant agreement to be executed
19 by the Executive or commissioners of each county prior to receiving Department of Job and
20 Family Services grant funds; and

22 WHEREAS, the County Department of Job and Family Services has received from the
23 State the standard subgrant agreement for State Fiscal Year ("SFY") 2016 (7/1/2015 through
24 6/30/2016) that sets forth the rights and responsibilities of the Ohio Department of Job and
25 Family Services and the County Department of Job and Family Services in relation to any grant
26 for workforce development activities, including, but not limited to, the Workforce Investment
27 Opportunity Act, the Wagner-Peyser Act, and Temporary Assistance to Needy Families
28 programs relating to workforce development, that are awarded for SFY 2016; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that is necessary and in the best interest of the County of Summit to authorize the County
32 Executive to execute said subgrant agreement for SFY 2016;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that;

37 SECTION 1

39 The County Executive is authorized to execute a subgrant agreement with the Ohio
40 Department of Job and Family Services for grants for the operation of workforce development
41 activities received by the County Department of Job and Family Services for State Fiscal Year
42 2016 (7/1/2015 though 6/30/2016). A copy of said subgrant agreement is attached hereto as
43 Exhibit A and incorporated herein by reference.

47 This Resolution is declared an emergency in the interest of the health, safety, and welfare
48 of the citizens of the County of Summit, and for the further reason that it is necessary to
49 immediately execute said subgrant agreement so that the County Executive's Department of Job
50 and Family Services is eligible to awarded grant funds from the Ohio Department of Job and
51 Family Services for SFY 2016.
