13 WHEREAS, the Board of Control, at its meeting held August 12, 2015, awarded a
14 purchase order with MNJ Technologies, under State Term Pricing, for Cisco network hubs,
15 switches, and power supplies for the new County offices located at 1180 South Main Street,
16 Akron, Ohio, in an amount not to exceed \$35,825.56, subject to confirmation by County
17 Council; and

19 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
20 that the aforementioned professional service contract with MNJ Technologies is necessary and in
21 the best interest of the County of Summit;

28 The award by the Board of Control of a purchase order with MNJ Technologies, under
29 State Term Pricing, for Cisco network hubs, switches, and power supplies for the new County
30 offices located at 1180 South Main Street, Akron, Ohio, in an amount not to exceed \$35,825.56,
31 is hereby confirmed and the County Executive is hereby authorized to execute such professional
32 service contract.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason to immediately
38 provide necessary information technology equipment for the new County offices located at 1180
39 South Main Street, Akron, Ohio.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
