7 **A Resolution confirming an award by the Board of Control of a IV-D intergovernmental**  
8 **agreement with the County Fiscal Office for processing of cash payments from child**  
9 **support clients, for a one-year term, from 7/1/15 through 6/30/16, in an amount not to**  
10 **exceed \$131,890.06, for the Prosecutor’s Child Support Enforcement Agency, and**  
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 19, 2015, awarded a IV-D  
14 intergovernmental agreement with the County Fiscal Office for processing of cash payments  
15 from child support clients for the County Prosecutor’s Child Support Enforcement Agency, for a  
16 one-year term, from 7/1/15 through 6/30/16, in an amount not to exceed \$131,890.06, subject to  
17 confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that the aforementioned IV-D intergovernmental agreement with the Fiscal Office is necessary  
21 and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

26 SECTION 1

28 The award by the Board of Control of a IV-D intergovernmental agreement with the  
29 County of Summit Fiscal Office for processing of cash payments from child support clients for  
30 the County Prosecutor’s Child Support Enforcement Agency (“CSEA”), for a one-year term,  
31 from 7/1/15 through 6/30/16, in an amount not to exceed \$131,890.06, is hereby confirmed and  
32 the County Executive is hereby authorized to execute such intergovernmental agreement.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the citizens of the County of Summit, and for the further reason to immediately  
38 provide for the processing of cash payments from child support clients for CSEA effective  
39 7/1/15.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
