8 **contract with Greenleaf Family Center to provide case management services to assist two-**
9 **parent assistance groups and Summit County Occupational Preparation Experience**
10 **participants in meeting mandated Ohio Works First work participation requirements, for a**
11 **one-year term, from 10/1/15 through 9/30/16, in an amount not to exceed \$133,110.00, for**
12 **the Executive's Department of Job and Family Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held August 26, 2015, awarded a
15 professional service contract with Greenleaf Family Center to provide case management services
16 to assist two-parent assistance groups and Summit County Occupational Preparation Experience
17 participants in meeting mandated Ohio Works First work participation requirements, for a one-
18 year term, from 10/1/15 through 9/30/16, in an amount not to exceed \$133,110.00, subject to
19 confirmation by County Council; and

21 WHEREAS, County Council finds and determines, after reviewing all pertinent
22 information, that the aforementioned professional service contract with Greenleaf Family Center
23 is necessary and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

30 The award by the Board of Control of a professional service contract with Greenleaf
31 Family Center to provide case management services to assist two-parent assistance groups and
32 Summit County Occupational Preparation Experience ("SCOPE") participants in meeting
33 mandated Ohio Works First ("OWF") work participation requirements, for a one-year term, from
34 10/1/15 through 9/30/16, in an amount not to exceed \$133,110.00, is hereby confirmed and the
35 County Executive is hereby authorized to execute such professional service contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and
40 welfare of the citizens of the County of Summit, and for the further reason to provide assistance
41 to two-parent households and SCOPE participants in meeting mandated OWF work participation
42 requirements effective 10/1/15.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
