7 **A Resolution repealing Resolution No. 2015-254 and authorizing the County Executive,**
8 **subject to approval of the Board of Control, to execute a professional service contract with**
9 **ABM Parking Services, Inc., dba ABM Parking Services, for operation and management of**
10 **the Summit County Parking Deck, for a 60-month term, from 8/1/15 through 7/31/20, in an**
11 **amount not to exceed \$440,000.00, for the Executive's Department of Administrative**
12 **Services – Division of Physical Plants, and declaring an emergency.**

14 WHEREAS, this Council previously approved Resolution No. 2015-254, which
15 authorized the County to enter into a professional services contract with ABM Parking Services
16 Inc., dba ABM Parking Services, for the operation and management of the Summit County
17 Parking Deck for the period of 8/1/15 through 7/31/20 in the amount of \$321,300.00; and

19 WHEREAS, the County Executive desires to repeal Resolution No. 2015-254 and to
20 obtain approval of a new professional services contract with ABM Parking Services for the
21 management and operation of the Summit County Parking Deck which would also include credit
22 card processing and payment reconciliation as part of that operation in an amount not to exceed
23 \$440,000.00 for the period of 8/1/15 through 7/31/20; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to repeal Resolution No.
27 2015-254 and to authorize the County Executive to execute the aforementioned professional
28 service contract with ABM Parking Services, subject to the approval of the Board of Control;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

35 Resolution No. 2015-254 is hereby repealed in its entirety.

39 The County Executive is hereby authorized, subject to approval of the Board of Control,
40 to execute a professional service contract with ABM Parking Services, Inc., dba ABM Parking
41 Services, subject to the approval of the Board of Control, for operation and management of the
42 Summit County Parking Deck, located at 200 South High Street, Akron, Ohio 44308, in Council
43 District 4, for a 60-month term, from 8/1/15 through 7/31/20, in an amount not to exceed
44 \$440,000.00.
