7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**  
8 **professional service contract with the Akron Community Service Center and Urban**  
9 **League, for youth employment and educational services, in an amount not to exceed**  
10 **\$27,000.00 (10.47% cumulative increase) for a total amount not to exceed \$285,000.00, for**  
11 **the Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held September 23, 2015, awarded  
14 Change Order No. 1 to a professional service contract with the Akron Community Service  
15 Center and Urban League for youth employment and educational services, in an amount not to  
16 exceed \$27,000.00 (10.47% cumulative increase) for a total amount not to exceed \$285,000.00,  
17 subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that Change Order No. 1 to the aforementioned professional service contract with the Akron  
21 Community Service Center and Urban League is necessary and in the best interest of the County  
22 of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:

27 SECTION 1

29 The award by the Board of Control of Change Order No. 1 to a professional service  
30 contract with the Akron Community Service Center and Urban League for youth employment  
31 and educational services, in an amount not to exceed \$27,000.00 (10.47% cumulative increase),  
32 for a total amount not to exceed \$285,000.00, is hereby confirmed and the County Executive is  
33 hereby authorized to execute such change order and any necessary related amendment to the  
34 professional service contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and  
39 welfare of the citizens of the County of Summit, and for the further reason to immediately  
40 provide for a necessary change order to a professional service contract with the Akron  
41 Community Service Center and Urban League for youth employment and educational services.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.
