7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **C&K Industrial to clean the County sewer system and inspect the system via video, in an**  
9 **amount not to exceed \$50,087.00, for the Engineer, and declaring an emergency.**

10  
11 WHEREAS, this Council previously adopted Resolution No. 2015-039, which authorized  
12 the County Executive to advertise for bids as needed for roadway engineering and construction  
13 projects, bridge engineering and construction projects, pavement maintenance projects and  
14 vehicles for the County Engineer's 2015 Capital Improvement Program and federal and state  
15 funded projects, for an estimated total cost not to exceed \$8,996,619.00; and

16  
17 WHEREAS, the Board of Control, at its meeting held on October 14, 2015, awarded a  
18 purchase contract with C&K Industrial to clean the County sewer system and inspect the system  
19 via video, subject to confirmation by County Council; and

21 WHEREAS, this Council previously adopted Resolution No. 2015-023, which adopted  
22 the County of Summit Capital Improvements Program for 2015-2020 and appropriated  
23 \$7,810,688.41 for projects in the 2015 Capital Improvement Program for the Executive's  
24 Department of Finance and Budget; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
27 that the aforementioned purchase contract with C&K Industrial is necessary and in the best of the  
28 County; and

30 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

33 SECTION 1

35 The award by the Board of Control of a purchase contract with C&K Industrial to clean  
36 the County sewer system and inspect the system via video, in an amount not to exceed  
37 \$50,087.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
38 purchase contract.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit, and for the further reason to immediately  
44 provide for the aforementioned county sewer cleaning and video inspection.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.
