7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Naragon Companies, Inc. for the 2015-2016 winter season plowing and salting of County**  
9 **parking lots, for an amount not to exceed \$1,380.00 per occurrence, for a total cost not to**  
10 **exceed \$35,000.00 for the winter season, for the Executive's Administrative Services-**  
11 **Division of Physical Plants, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2015-372, which authorized  
14 the Executive to advertise for bids for the 2015-2016 winter season plowing and salting of  
15 County parking lots, for an estimated total cost not to exceed \$35,000.00; and

17 WHEREAS, the Board of Control, at its meeting held October 21, 2015, awarded a  
18 purchase contract to Naragon Companies for the 2015-2016 winter season plowing and salting of  
19 County parking lots, in an amount not to exceed \$1,380.00 per occurrence, for a total cost not to  
20 exceed \$35,000.00 for the winter season, subject to confirmation by County Council; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that the aforementioned purchase contract with Naragon Companies, Inc. is necessary and in the  
24 best interest of the County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that:

29 SECTION 1

31 The award by the Board of Control of a purchase contract with Naragon Companies, Inc.  
32 for the 2015-2016 winter season plowing and salting of County parking lots, in an amount not to  
33 exceed \$1,380.00 per occurrence, for a total cost not to exceed \$35,000.00 for the winter season,  
34 is hereby confirmed and the County Executive is hereby authorized to execute such purchase  
35 contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and  
40 welfare of the citizens of the County of Summit, and for the further reason to immediately  
41 provide for plowing and salting of County parking lots in the 2015-2016 winter season.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.


