7 **A Resolution confirming an award by the Board of Control of a three-year professional**
8 **service contract with Courtview Justice Solutions, Inc., as a Best Practical Source, to**
9 **provide software and system maintenance services, from 1/1/16 through 12/31/18, with two**
10 **options to renew for an additional one year term, in an amount not to exceed \$197,388.00,**

13 WHEREAS, the Board of Control, at its meeting held on October 21, 2015, awarded a
14 three-year professional service contract with Courtview Justice Solutions, Inc. as a Best Practical
15 Source, to provide software and system maintenance services, from 1/1/16 through 12/31/18,
16 with two options to renew for an additional one year term, in an amount not to exceed
17 \$197,388.00, approved by the IT board on 10/20/15, subject to confirmation by County Council;

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned professional service contract with Courtview Justice Solutions, Inc. is
22 necessary and in the best interest of the County of Summit;

29 The award by the Board of Control of a three-year professional service contract with
30 Courtview Justice Solutions, Inc., as a Best Practical Source, to provide software and system
31 maintenance services, from 1/1/16 through 12/31/18, with two options to renew for an additional
32 one year term, in an amount not to exceed \$197,388.00, is hereby confirmed and the County
33 Executive is hereby authorized to execute such professional services contract.

38 welfare of the citizens of the County of Summit, and for the further reason to immediately
39 provide software and system maintenance services, for the Court of Common Pleas-Probate




