7 **A Resolution confirming an award by the Board of Control of a purchase order with**

11 WHEREAS, the Board of Control, at its meeting held October 21, 2015, awarded a
12 purchase order with Montrose Ford for one 2016 Ford AWD Explorer SUV, under CUE pricing,
13 subject to confirmation by County Council; and

15 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
16 that the aforementioned purchase order with Montrose Ford is necessary and in the best interest
17 of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a purchase order with Montrose Ford for one 2016
25 Ford AWD Explorer SUV, under CUE pricing, in a total amount not to exceed \$28,090.09, is
26 hereby confirmed and the County Executive is hereby authorized to execute such purchase order.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide a vehicle that provides K-9 bomb detection dog transportation.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,
