8 **A Resolution authorizing the County Executive to execute any documents necessary to**
9 **accept an award of a Federal Fiscal Year 2016 Selective Traffic Enforcement Program**
10 **Overtime grant from the Ohio Department of Public Safety, through its Ohio Traffic**
11 **Safety Office, for selective traffic enforcement, for the period 10/1/15 to 9/30/16, in the**
12 **amount of \$35,604.96, with no local cash match requirement, and appropriating funds, for**
13 **the Sheriff, and declaring an emergency.**

15 WHEREAS, Ohio Department of Public Safety ("ODPS"), through its Ohio Traffic
16 Safety Office ("OTSO"), has awarded County of Summit Sheriff's Office a Federal Fiscal Year
17 2016 Selective Traffic Enforcement Program ("STEP") Overtime grant, for selective traffic
18 enforcement, for the period 10/1/15 through 9/30/16, in the amount of \$35,604.96, with no local
19 cash match requirement, in order to operate a STEP program in the County of Summit; and

21 WHEREAS, the STEP grant has provided funding for the past 16 years to the Sheriff's
22 Office for overtime work in order to conduct selective traffic enforcement, public awareness, and
23 education in Summit County; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is
26 necessary and in the best interest of the County of Summit to authorize the County Executive to
27 execute any documents necessary to accept the aforementioned STEP Overtime grant from the
28 ODPS through OTSO, and to appropriate these grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept
36 an award of a Federal Fiscal Year 2016 Selective Traffic Enforcement Program Overtime grant
37 from the Ohio Department of Public Safety, through its Ohio Traffic Safety Office, for selective
38 traffic enforcement, for the period 10/1/15 to 9/30/16, in the amount of \$35,604.96, with no local
39 cash match requirement.


