7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award of a 2014 Title II Formula Grant from the Ohio Department of Youth**  
9 **Services to impact minority youth arrests in Summit County, for the period 10/1/15**  
10 **through 9/30/16, in the amount of \$9,693.00, and appropriating said grant funds and**  
11 **\$5,000.00 in supplemental RECLAIM Ohio funds, for a total amount of \$14,693.00, for the**  
12 **Court of Common Pleas - Juvenile Division, and declaring an emergency.**

13  
14 WHEREAS, the Ohio Department of Youth Services has awarded the Court of Common  
15 Pleas - Juvenile Division a 2014 Title II Formula Grant from the Ohio Department of Youth  
16 Services, for the period 10/1/15 through 9/30/16, in the amount of \$9,693.00, with no local cash  
17 match requirement; and

18  
19 WHEREAS, these funds will be used to provide 25% of the costs of the salary of a  
20 probation officer; and

21  
22 WHEREAS, RECLAIM Ohio funds, in the amount of \$5,000.00, will be used to  
23 supplement the 2014 Title II Formula Grant by paying for benefits associated with the 25% of  
24 salary costs covered by said grant;

25  
26 WHEREAS, it is necessary to appropriate the 2014 Title II Formula Grant and the  
27 RECLAIM Ohio funds, in a total amount of \$14,693.00; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
30 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
31 execute any documents necessary to accept the award of the aforementioned 2014 Title II  
32 Formula Grant and to appropriate said grant funds and RECLAIM Ohio funds, in a total amount  
33 of \$14,693.00;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
36 of Ohio, that:

40 The County Executive is hereby authorized to execute any documents necessary to accept  
41 the award of a 2014 Title II Formula Grant from the Ohio Department of Youth Services to  
42 impact minority youth arrests in Summit County, for the period 10/1/15 through 9/30/16, in the  
43 amount of \$9,693.00. The expenditure of supplemental RECLAIM Ohio funds, in the amount of  
44 \$5,000.00, is hereby authorized to supplement the 2014 Title II Formula Grant to provide  
45 benefits associated with the 25% of salary costs of a probation officer funded by said grant.

27 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
28 effect and be in force at the earliest time provided by law.
