7 **A Resolution revising the classification specification and salary schedule for the non-**
8 **bargaining, unclassified part-time position of Direct Indictment Program Liaison, #4025A**
9 **to make the position full-time, renumbering the position as #40026 and revising the**
10 **County's 2015 Staffing Report to include said position, for the Sheriff and the Executive's**
11 **Department of Human Resources, and declaring an emergency.**

13 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10)
14 of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
15 Codified Ordinances to establish classifications, classification specifications and pay/salary
16 schedules for all County employees; and

18 WHEREAS, the County Sheriff wishes the Direct Indictment Program Liaison to have
19 the ability to work full-time rather than part-time; and

21 WHEREAS, the County Sheriff requests that this Council revise the classification
22 specification and salary schedule for the non-bargaining, unclassified part-time position of Direct
23 Indictment Program Liaison, #4025A to make the position full-time, renumber the position as
24 #40026 and revise the County's 2015 Staffing Report to include said position in order to permit
25 the Direct Indictment Program Liaison to work full-time;

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 it is necessary and in the best interest of the County of Summit to revise the classification
29 specification and salary schedule for the non-bargaining, unclassified part-time position of Direct
30 Indictment Program Liaison, #4025A to make the position full-time, renumber the position as
31 #40026 and revise the County's 2015 Staffing Report for the aforementioned reason;

17 #4025A to make the position full-time, renumber the position as #40026 and revise the County's
18 2015 Staffing Report to include said position in order to permit the Direct Indictment Program
19 Liaison to work full-time.

24 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
25 and be in force at the earliest time provided by law.
