7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Aramark Uniform Services, to provide uniform services, for a three-year term, from**  
9 **11/1/2015 through 10/31/2018, in an amount not to exceed \$80,043.60, for the Executive's**  
10 **Department of Environmental Services, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2012-318, which authorized  
13 a purchase contract with Aramark Uniform Services, to provide uniform services, for a three-  
14 year term, with one option to renew for an additional three-year term, in an amount not to exceed  
15 \$80,043.60, for the Executive's Department of Environmental Services; and

17 WHEREAS, the Board of Control, at its meeting held on October 28, 2015, awarded a  
18 purchase contract with Aramark Uniform Services, to provide uniform services, for a three-year  
19 term, in an amount not to exceed \$80,043.60, subject to confirmation by County Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
22 that the aforementioned purchase contract with Aramark Uniform Services is necessary and in  
23 the best interest of the County of Summit; and

25 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that:

30 The award by the Board of Control of a purchase contract with Aramark Uniform  
31 Services to provide uniform services, for a three-year term, from 11/1/2015 through 10/31/2018,  
32 in an amount not to exceed \$80,043.60, for the Executive's Department of Environmental  
33 Services, is hereby confirmed and the County Executive is hereby authorized to execute such  
34 purchase contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and  
39 welfare of the citizens of the County of Summit, and for the further reason to immediately  
40 provide for the uniform services at the Executive's Department of Environmental Services.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take  
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
46 effect and be in force at the earliest time provided by law.






