7 **A Resolution declaring the determination of this Council to proceed with the construction**
8 **of the Columbine Service Area Sanitary Sewer Improvement Project (Q-948), as approved**
9 **in Resolution No. 2015-271, in Springfield Township and the Village of Mogadore, for the**
10 **Department of Environmental Services, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution 2015-271, which approved the
13 detailed plans, specifications and tentative assessment for the Columbine Service Area Sanitary
14 Sewer Improvement Project (Q-948), in Springfield Township and the Village of Mogadore, in
15 Council District 8; and

17 WHEREAS, this Council conducted a hearing on October 5, 2015 at 4:30 p.m., where
18 objections to the Project, the tentative assessment, or to the boundaries of the assessment district
19 were to be heard; and

21 WHEREAS, this Council ratified the Project's character and termini, boundaries of the
22 assessment district, and tentative assessment in Res. No. 2015-441; and

24 WHEREAS, the County Executive has notified all residents who have objected to the
25 Improvement of the Council meetings in which this Resolution shall be considered; and

27 WHEREAS, this Council finds and determines after reviewing all pertinent information,
28 including minutes of the aforementioned hearing, the detailed plans, specifications, estimate of
29 cost and tentative assessment of the Project, that the Project as approved in Resolution No. 2015-
30 271, and ratified in Resolution No. 2015-441, should proceed with construction;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 This Council determines that the Columbine Service Area Sanitary Sewer Improvement
38 Project (Q-948), in Springfield Township and the Village of Mogadore, in Council District 8, as
39 approved in Resolution No. 2015-271, and as ratified in Resolution No. 2015-441, shall proceed
40 to construction.

44 This Resolution is declared an emergency in the interest of the health, safety and welfare
45 of the citizens of the County of Summit and for the further reason to provide for the immediate
46 construction of sanitary sewage facilities in Springfield Township and the Village of Mogadore,
