7 **A Resolution authorizing the County Executive to execute a quit-claim deed to transfer**
8 **certain County-owned real property located in the City of Twinsburg, and identified as**
9 **Parcel No. 64-09474 in the Summit County Records, to the City of Twinsburg, for the**
10 **Executive, and declaring an emergency.**

11
12 WHEREAS, the County currently owns a parcel of real property located in the City of
13 Twinsburg, in Council District 1, and identified as Parcel No. 64-09474 in the Summit County
14 Records; and

15
16 WHEREAS, Parcel No. 64-09474, a map of which is attached as Exhibit A, is currently
17 vacant land located next to State Route 91 and is not being utilized for any purpose by the
18 County; and

20 WHEREAS, the County has no reason to retain control of this parcel of land and after the
21 transfer of said properties the City of Twinsburg could better maintain the property and utilize it
22 for their stormwater management facility; and

24 WHEREAS, Section 177.16(e) of the Codified Ordinances of the County of Summit
25 authorizes the transfer of County-owned real property to a subdivision of the State of Ohio upon
26 approval of this Council; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County to authorize the County Executive to
30 execute a quit-claim deed to transfer the aforementioned property to the City of Twinsburg.

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

35 SECTION 1

37 This Council authorizes the County Executive to execute a quit-claim deed to transfer
38 certain County-owned real property located in the City of Twinsburg, in Council District 1, and
39 identified as Parcel No. 64-09474 in the Summit County Records, to the City of Twinsburg.

41 SECTION 2

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the citizens of the County of Summit, and for the further reason that it will
45 immediately authorize the transfer of the property to avoid any continued maintenance obligation
46 of the County and allow the City of Twinsburg to utilize the property.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
52 effect and be in force at the earliest time provided by law.
