7 **An Ordinance amending Section 339.12 of the Codified Ordinances of the County of**  
8 **Summit, entitled “Bridge Weight Limits”, to remove a 20-ton load limit on the Coventry**  
9 **Road Bridge over Mud Run, located in the City of Barberton, for the Engineer, and**  
10 **declaring an emergency.**

11  
12 WHEREAS, Section 339.12 of the Codified Ordinances of the County of Summit entitled  
13 “Bridge Weight Limits,” limits the gross weight of vehicles authorized to travel on certain  
14 bridges that are inspected by the County Engineer; and

15  
16 WHEREAS, due to the recent removal of excess asphalt, the Engineer concludes that the  
17 20-ton load limitation should be removed from the Coventry Road Bridge over Mud Run,  
18 located in the City of Barberton, in Council District 7; and

19  
20 WHEREAS, the removal of a bridge load limit requires amendment of Section 339.12;  
21 and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
24 that the acceptance and approval of the aforementioned amendment to Section 339.12 is  
25 necessary and in the best interest of the County of Summit;

27 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State  
28 of Ohio, that;

30 SECTION 1

31  
32 Section 339.12 of the Codified Ordinances of the County of Summit, entitled “Bridge  
33 Weight Limits,” is amended as follows:

34  
35 **“339.12 BRIDGE WEIGHT LIMITS.**

36 (a) No person shall operate any vehicle upon any of the following bridges, if such vehicle,  
37 the gross weight of which, exceeds the maximum load limit specified for each respective bridge:

<u>Bridge</u>	<u>Maximum Load Limit</u>
(1) Knox Boulevard Bridge (COP-305-0033) over Pigeon Creek	22 tons
(2) Riverview Road Bridge (AKR-227-0023) over Furnace Run	25 tons
(3) Wright Road Bridge (COP-206-0150) over Pigeon Creek	40 tons
(4) Coventry Road Bridge (BAR-017-0084) over Mud Run	20 tons

6 (b) The County Engineer shall place and maintain, at both ends of each respective bridge,  
7 signs of substantial construction to conspicuously indicate the maximum weight limitations of  
8 vehicle and load as provided herein.

9  
10 (c) In addition to criminal prosecution for violation of this section, in case of any injury to  
11 any bridge by reason of the violation of the weight limitation, damages shall be recovered by  
12 civil action on behalf of the County.

13  
14 (d) Whoever violates any provision of this section is guilty of a minor misdemeanor on a first  
15 offense; on a second offense within one year after the first offense, the person is guilty of a  
16 misdemeanor of the fourth degree; on each subsequent offense within one year after the second  
17 offense, the person is guilty of a misdemeanor of the third degree.”

19 SECTION 2

20  
21 This Ordinance is hereby declared an emergency in the interest of the health, safety and  
22 welfare of the citizens of the County of Summit, and for the further reason to amend Section  
23 339.12 to permit the return of a necessary bridge to full use.

24  
25 SECTION 3

26  
27 Provided this Ordinance receives the affirmative vote of eight members, it shall take  
28 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
29 effect and be in force at the earliest time provided by law.

30  
31 SECTION 4

32  
33 It is found and determined that all formal actions of this Council concerning and relating  
34 to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all  
35 deliberations of this Council and of any of its committees that resulted in such formal action,  
36 were in meetings open to the public, in compliance with all legal requirements, including Section  
37 121.22 of the Ohio Revised Code.




