7 **A Resolution requesting the County Fiscal Officer to advance all tax levy funds for tax year**  
8 **2016/collection year 2017 to the County of Summit, pursuant to Section 321.34 of the Ohio**  
9 **Revised Code, for the Executive's Department of Finance and Budget, and declaring an**  
10 **emergency.**

11  
12 WHEREAS, pursuant to Section 321.34 of the Ohio Revised Code, when requested by  
13 resolution by a township, municipal corporation, board of education or any other political  
14 subdivision or taxing authority whose funds derived from taxes or other sources are payable by  
15 law to the County Fiscal Officer, the Fiscal Officer shall pay to said local authorities any money  
16 that may be in the County treasury to the accounts of the local authorities for the current fiscal  
17 year in which the request is made; and

19 WHEREAS, it is necessary to request the County Fiscal Officer to advance all tax levy  
20 funds for tax year 2016/collection year 2017; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County to request the County Fiscal Officer to  
24 advance all tax levy funds for tax year 2016/collection year 2017 to the County of Summit.

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that:

29 SECTION 1

31 The County Fiscal Officer is hereby requested to advance, pursuant to Section 321.34, all  
32 tax levy funds for tax year 2016/collection year 2017 to the County of Summit.

34 SECTION 2

36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the citizens of the County of Summit, and for the further reason that it will  
38 immediately allow the County Fiscal Officer to advance all tax levy funds for tax year  
39 2016/collection year 2017.

41 SECTION 3

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
