7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award of a 2015 Title II Formula Grant from the Ohio Department of Youth**
9 **Services, for the period 10/1/16 through 9/30/17, in the amount of \$9,185.00, and**
10 **appropriating said grant funds, and \$5,000.00 in supplemental RECLAIM Ohio funds, for**
11 **a total amount of \$14,185.00, and authorizing the expenditure of \$5,000.00 in RECLAIM**
12 **Ohio funds for benefits for a probation officer, for the Court of Common Pleas- Juvenile**
13 **Division, and declaring an emergency.**

15 WHEREAS, the Ohio Department of Youth Services has awarded the Court of Common
16 Pleas- Juvenile Division a 2015 Title II Formula Grant from the Ohio Department of Youth
17 Services, for the period 10/1/16 through 9/30/17, in the amount of \$9,185.00, with no local cash
18 match requirement; and

20 WHEREAS, these funds will be used to provide 25% of the costs of the salary of the
21 probation officer; and

23 WHEREAS, RECLAIM Ohio funds, in the amount of \$5,000.00 will be used to
24 supplement the 2015 Title II Formula Grant by paying for benefits associated with the 25% of
25 the salary costs covered by said grant;

26
27 WHEREAS, it is necessary to appropriate the 2015 Title II Formula Grant and the
28 RECLAIM Ohio funds, in a total amount of \$14,185.00; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that it is necessary and in the best interest of the County of Summit to authorize the County
32 Executive to execute any documents necessary to accept the award of the aforementioned 2015
33 Title II Formula Grant and to appropriate said grant funds and RECLAIM Ohio funds, in a total
34 amount of \$14,185.00, and to authorize the expenditure of RECLAIM Ohio funds for benefits
35 for a probation officer;

37 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

42 The County Executive is hereby authorized to execute any documents necessary to accept
43 an award of a Title II Formula Grant from the Ohio Department of Youth Services, for the period
44 10/1/16 through 9/30/17, in the amount of \$9,185.00, with no local cash match requirement. The
45 expenditure of supplemental RECLAIM Ohio funds, in the amount of \$5,000.00, is hereby
46 authorized to supplement the 2015 Title II Formula Grant to provide benefits associated with the
47 25% of salary costs of a probation officer funded by said grant.
