7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**
8 **professional service contract with Asian Services in Action, Inc. to provide onsite**
9 **employment services to refuge clients participating in the Summit County Occupational**
10 **Preparation Experience program, for a one-year term, from 10/1/16 through 9/30/17, in an**
11 **amount not to exceed \$55,000.00 (a 97.52% cumulative increase) for the Executive's**
12 **Department of Job and Family Services, and declaring an emergency.**

14 WHEREAS, County Council previously adopted Resolution No. 2016-297, which
15 confirmed an award by the Board of Control of a professional service contract with Asian
16 Services in Action, Inc. to provide onsite employment services for refuge clients participating in
17 the Summit County Occupational Preparation Experience program, for a one-year term, from
18 10/1/16 through 9/30/17, in an amount not to exceed \$56,400.00; and

20 WHEREAS, the Board of Control, at its meeting held October 12, 2016, awarded Change
21 Order No. 1 to the aforementioned professional service contract with Asian Services in Action,
22 Inc. to provide onsite employment services to refuge clients participating in the Summit County
23 Occupational Preparation Experience program, for a one-year term, from 10/1/16 through
24 9/30/17, in an amount not to exceed \$55,000.00 (a 97.52% cumulative increase) for a total
25 amount not to exceed \$111,400.00, subject to confirmation by County Council; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information
28 that the aforementioned Change Order No. 1 to the professional service contract with Asian
29 Services in Action, Inc. is necessary and in the best interest of the County of Summit;

31 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

36 The award by the Board of Control of Change Order No. 1 to a professional service
37 contract with Asian Services in Action, Inc. to provide onsite employment services to refuge
38 clients participating in the Summit County Occupational Preparation Experience program, for a
39 one-year term, from 10/1/16 through 9/30/17, in an amount not to exceed \$55,000.00 (a 97.52%
40 cumulative increase), for a total amount not to exceed \$111,400.00, is hereby confirmed and the
41 County Executive is hereby authorized to execute such change order.

45 This Resolution is hereby declared an emergency in the interest of the health, safety and
46 welfare of the citizens of the County of Summit, and for the further reason to immediately
47 provide additional onsite employment services to refuge clients participating in the Summit
