7 **A Resolution authorizing the County Executive to conduct an auction, through Akron Auto**
8 **Auction, of various surplus Sheriff's Office vehicles, with a total fair market value**
9 **exceeding \$38,000.00, for a cost to the County of an amount not to exceed \$3,800.00, and**
10 **authorizing the Executive to execute any documents with Akron Auto Auction necessary to**
11 **conduct said auction, for the Executive, and declaring an emergency.**

13 WHEREAS, the County Sheriff's Office has various surplus vehicles as set forth in
14 attached Exhibit A; and

15
16 WHEREAS, the Sheriff's Office wishes to have the County Executive auction said
17 vehicles, which have a total fair market value exceeding \$38,000.00, which requires the approval
18 of County Council pursuant to Section 177.18 of the Codified Ordinances of the County of
19 Summit; and

21 WHEREAS, the Executive intends to conduct said auction through Akron Auto Auction
22 at a cost to the County of \$125.00 per vehicle for the auction including pick up of each unit, and
23 \$65.00 per vehicle in the event the unit needs towed, for a total cost to the County of an amount
24 not to exceed \$3,800.00; and

26 WHEREAS, it is necessary to authorize the Executive to execute any documents with
27 Akron Auto Auction necessary to conduct said auction; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
31 conduct an auction, through Akron Auto Auction, of various surplus Sheriff's Office vehicles, as
32 set forth in attached Exhibit A, with a total fair market value exceeding \$38,000.00, for a cost to
33 the County of an amount not to exceed \$3,800.00, and to authorize the Executive to execute any
34 documents with Akron Auto Auction necessary to conduct said auction;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

39 SECTION 1

41 The County Executive is hereby authorized to conduct an auction, through Akron Auto
42 Auction, of various surplus Sheriff's Office vehicles, as set forth in Exhibit A, attached to this
43 Resolution and incorporated herein as if fully restated, with a total fair market value exceeding
44 \$38,000.00. The cost to the County shall not exceed the amount of \$125.00 per vehicle for the
45 auction including pick up of each unit, and \$65.00 per vehicle in the event the unit needs to be
46 towed, for a total cost to the County of an amount not to exceed \$3,800.00. The Executive is
47 further authorized to execute any documents with Akron Auto Auction necessary to conduct said
48 auction.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the citizens of the County of Summit and for further purpose of immediately
8 authorizing the Executive to conduct an auction of various surplus County vehicles through
9 Akron Auto Auction.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.

19 It is found and determined that all formal actions of this Council concerning and relating
20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
21 deliberations of this Council and of any of its committees that resulted in such formal action,
22 were in meetings open to the public, in compliance with all legal requirements, including Section
23 121.22 of the Ohio Revised Code.
