7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award from the Ohio Department of Mental Health and Addiction Services of**  
9 **State Fiscal Year 2017 Specialized Docket Payroll Subsidy Project grant funds, for the**  
10 **period 7/1/16 through 6/30/17, in the amount of \$106,903.00, with no local cash match**  
11 **requirement, and appropriating said grant funds, for the Court of Common Pleas-Adult**  
12 **Probation Department, and declaring an emergency.**

14 WHEREAS, the Ohio Department of Mental Health and Addiction Services  
15 (“ODMHAS”) has awarded to the County of Summit Court of Common Pleas-Adult Probation  
16 Department State Fiscal Year (“SFY”) 2017 Specialized Docket Payroll Subsidy Project grant  
17 funds, for the period 7/1/16 through 6/30/17, in the amount of \$106,903.00, with no local cash  
18 match requirement, which will be used to subsidize the salaries and benefits of adult probation  
19 officers assigned to the Veteran’s Court, Turning Point Program and Reentry Court; and

21 WHEREAS, it is necessary to authorize the County Executive to execute any documents  
22 necessary to accept the SFY 2017 Specialized Docket Payroll Subsidy Project grant funds from  
23 ODMHAS and to appropriate said grant funds; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
27 execute any documents necessary to accept the aforementioned grant funds from ODMHAS and  
28 to appropriate said grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

35 The County Executive is hereby authorized to execute any documents necessary to accept  
36 an award from the Ohio Department of Mental Health and Addiction Services (“ODMHAS”) of  
37 a State Fiscal Year (“SFY”) 2017 Specialized Docket Payroll Subsidy Project grant funds, in the  
38 amount of \$106,903.00, with no local cash match requirement, which will be used to subsidize  
39 the salaries and benefits of adult probation officers assigned to the Veteran’s Court, Turning  
40 Point Program and Reentry Court.

12 of the citizens of the County of Summit and for the further purpose of immediately authorizing  
13 the Executive to execute any documents necessary to accept the SFY 2017 Specialized Docket  
14 Payroll Subsidy Project grant from ODMHAS and to appropriate said grant funds.

19 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
