7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Finley Fire Equipment for twenty supplied air respirator units for the Summit County**  
9 **Special Operations Response Team, Technical Rescue Branch and Hazardous Materials**  
10 **Response Branch, in an amount not to exceed \$54,220.00, for the Executive's Department**  
11 **of Law, Insurance, and Risk Management-Division of Emergency Management- Division of**  
12 **Public Safety, and declaring an emergency.**

14 WHEREAS, this Council previously adopted Resolution No. 2016-198, which authorized  
15 the County Executive to advertise for bids for the purchase of twenty supplied air respirator  
16 units, for an estimated cost not to exceed \$63,748.00; and

18 WHEREAS, the Board of Control, at its meeting held November 9, 2016, awarded a  
19 purchase contract with Finley Fire Equipment for twenty supplied air respirator units for the  
20 Summit County Operations Response Team, Technical Rescue Branch and Hazardous Materials  
21 Response Branch, in an amount not to exceed \$54,220.00, subject to confirmation by County  
22 Council; and

24 WHEREAS, this Council finds and determines after reviewing all pertinent information,  
25 that the aforementioned purchase contract with Finley Fire Equipment is necessary and in the  
26 best interest of the County of Summit;

28 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

31 SECTION 1

33 The award by the Board of Control of a purchase contract with Finley Fire Equipment for  
34 twenty supplied air respirator units for the Summit County Special Operations Response Team,  
35 Technical Rescue Branch and Hazardous Materials Response Branch, in an amount not to exceed  
36 \$54,220.00, is hereby authorized and the County Executive is hereby authorized to execute such  
37 purchase contract.

39 SECTION 2

41 This Resolution is hereby declared an emergency in the interest of the health, safety and  
42 welfare of the citizens of the County of Summit, and for the further reason to immediately  
43 provide for a necessary purchase contract with Finley Fire Equipment for the Special Operations  
44 Response Team, Technical Rescue Branch and Hazardous Materials Response Branch.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.




