7 **A Resolution authorizing the County Executive to advertise for bids for the Safety Building**  
8 **Elevator and Fire Alarm Improvement Project, for an estimated total cost not to exceed**  
9 **\$786,500.00, for the Executive's Department of Administrative Services- Physical Plants**  
10 **Division, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the Safety Building  
16 Elevator and Fire Alarm Improvement Project, located at 53 University Avenue, Akron, Ohio  
17 44308 in Council District 4; and

19 WHEREAS this Council finds and determines, after reviewing all pertinent information  
20 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
21 advertise for bids for the aforementioned project;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

28 The County Executive is authorized to advertise for bids for the Safety Building Elevator  
29 and Fire Alarm Improvement Project, located at 53 University Avenue, Akron, Ohio 44308, in  
30 Council District 4, for an estimated total cost not to exceed \$786,500.00; and

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of the health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the  
36 Executive to immediately advertise for bids for the Safety Building Elevator and Fire Alarm  
37 Improvement Project.

39 SECTION 3

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating  
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
49 deliberations of this Council and of any of its committees that resulted in such formal action,

51 121.22 of the Ohio Revised Code.


