7 **A Resolution confirming an award by the Board of Control of a construction contract with**  
8 **Rudzik Excavating, Inc. for the Brandywine/Olde 8 Trunk Sanitary Sewer Replacement**  
9 **Project Q-182, for a total amount not to exceed \$243,379.40, for the Executive's**  
10 **Department of Sanitary Sewer Services, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held December 7, 2016, awarded a  
13 construction contract with Rudzik Excavating, Inc. for the Brandywine/Olde 8 Trunk Sanitary  
14 Sewer Replacement Project Q-182, in the City of Macedonia, in Council District 1, in an amount  
15 not to exceed \$243,379.40, subject to confirmation by County Council; and

17 WHEREAS, County Council finds and determines, after reviewing all pertinent  
18 information that the renewal of the aforementioned construction contract is necessary and in the  
19 best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a construction contract with Rudzik Excavating,  
27 Inc. for the Brandywine/Olde 8 Sanitary Sewer Replacement Project Q-182, in the City of  
28 Macedonia, in Council District 1, in an amount not to exceed \$243,379.40, is hereby confirmed  
29 and the County Executive is hereby authorized to execute such a construction contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the citizens of the County of Summit, and to immediately provide for completion of  
35 the Q-182 Brandywine/Olde 8 Trunk Sanitary Sewer Replacement Project.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take  
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,

49 121.22 of the Ohio Revised Code.
